### Definition

- The term '**Contribution**' refers to the publication listed in Item 4 above, which can be a book, book chapter, monograph, article, manuscript, essay, or any other form of medium.
- The term '**Author**' refers to the author listed in Item 5 above.
- The term '**Publisher**' refers to Rockefeller Publishing Co., New York, NY.
- **PDF** stands for **Portable Document Format**. It is a file format developed by Adobe.com to present documents consistently across different devices and platforms.
- **DOI** stands for **Digital Object Identifier**. It is a unique alphanumeric string assigned to digital content, such as journal articles, research papers, or eBooks. The purpose of a DOI is to provide a permanent link to the content, even if its location (URL) changes over time.

**Disclaimer:** If a publication involves multiple authors, the term 'Author' refers to the corresponding author, acting on behalf of all co-authors.

### Open Access policy

Rockefeller Publishing Co. publishes all Contributions under the open access model and adheres to the Creative Commons Attribution License 4.0 (CC BY 4.0). This license guarantees that the copyrights of the Contribution remain with the authors. The license allows anyone to read, download, distribute, and use the content of the Contribution freely, thus promoting wider dissemination and utilization of the knowledge contained within.

### § 1 – Author Consent Agreement

This agreement is entered into by the **Publisher** and the **Author** regarding the publication of the Author's Contribution as an open-access publication.

***\*Note:** Once the Creative Commons License (CC BY 4.0) is applied to a work, it cannot be revoked. This ensures that permissions granted under the license—such as sharing, adapting, or using the work—remain intact, provided users adhere to the license's terms. While the author retains copyright ownership and may release the work under a different license in the future, the original CC BY 4.0 license remains permanently valid for all who accessed the work during its initial licensing.*

### **§ 1.1 – Copyright Ownership**

The Author retains full ownership of the copyright to the Contribution.

### **§ 2 – Rights granted**

By signing this document, the **Author** grants the **Publisher** the following rights for the Contribution:

1. The Publisher can use, display, reproduce, publish, and distribute the Contribution, or parts of it, individually or alongside other works, in any language and in any format.
2. Adaptation and communication: The Publisher has the right to translate, publicly perform, store, archive, lease or lend and sell the Contribution or parts thereof individually or together with other works in any language (e.g., printed version, printed hardcover book, printed softcover book, printed magazine, printed booklet, print to order).
3. All formats and media: The Contribution can be used in any current or future format, including books (hardcover, softcover, etc.), electronic devices, multimedia versions, and data networks like the internet.
4. Advertising and promotion: The Publisher may use parts of the Contribution, such as text, illustrations, or tables, for advertising purposes.

The electronic version of the Contribution will be marked as “open access” and will feature an open access label in the Publisher’s website <https://rockefellerpub.com>.

#### **§ 3.1 – Attribution**

The Publisher agrees to provide proper attribution to the Author for the Content and any derivative works, in any medium or format, wherever they are published, sold, or distributed.

### **§ 4 – Copyright Exceptions**

The following copyright exceptions apply:

1. Contribution prepared by U.S. government officers or employees as part of their official duties may not have a basis for copyright in the United States. If the Contribution was created under a U.S. government contract, but the Author is not a U.S. government employee, the Publisher grants the U.S. government royalty-free permission to (i) Reproduce all or parts of the Contribution, and (ii) Authorize others to do so for U.S. government purposes.
2. If the Contribution was prepared or published under the direction or control of Her Majesty (the constitutional monarch) or any Crown government department, copyright will belong to Her Majesty unless there is a specific agreement with the Author.
3. If the Author is an officer or employee of the U.S. government or of the Crown, this status will be explicitly noted on the signature page of the agreement.

### **§ 5 – Warranties**

The Author guarantees that the Contribution is an original work and does not infringe on the rights of any third party.

All necessary permissions for any third-party material included in the Contribution have been obtained. The Author must obtain and document such permissions, including open access licenses where applicable. The Author is responsible for citing the sources of these permissions in the manuscript and for storing the signed permission documents.

The Author warrants that is fully entitled to grant the rights outlined in Clause 2, “Rights Granted,” and that has not previously assigned these rights to any third party.

The Author ensures that the Contribution (i) does not contain any libelous, defamatory, or unlawful statements, and (ii) does not infringe on any copyrights, trademarks, patents, statutory rights, or proprietary rights of third parties, including those obtained through licenses.

### **§ 6 – No Fees or Charges**

The Author acknowledges that the Publisher’s open-access policy ensures that no fees are required from the Author for the publication, distribution, or availability of the Book

### **§ 7 – Publication and distribution**

The Publisher has the right to have the Contribution peer-reviewed by external reviewers of its choice. Once the Contribution is ready for publication, the Publisher will manage the publication and distribution in electronic formats at its own expense and risk.

## **§ 8 – Governing Jurisdiction**

This agreement shall be governed by, and shall be construed in accordance with, the laws of the State of New York. The courts located in New York shall have exclusive jurisdiction over any disputes arising out of or related to this agreement.

Either party may terminate this Agreement immediately by providing written notice to the other party in the event of a material breach of the terms of the Agreement that cannot be remedied, or if the breaching party fails to remedy the breach within 28 days of receiving written notice to do so.
